To Whom It May Concern:

- (ii) Stationery: Pen holders; pens and pencils; rulers; erasers; scissors (sizes 13cm or 15cm, used for school); sharpeners; folders; files made of plastic and/or cardboard with a lever-arch and/or ring binder; plastic pencil cases; and stationery sets combining any of the herein-mentioned stationery items.
- (iii) Paper goods: Copy books and/or exercise notebooks; diaries; notebooks; drawing albums; stickers consisting of sticky notebook labels in blister packs and plastic packs; colored paper/cardboard; colored foil paper; glued paper consisting of sticky notes in a paper block format; colored creative sets consisting of: a set of colored paper, colored cardboard or colored foil art for art classes; coloring creative sets consisting of: a set of coloring sheets and line art for coloring, painting and/or color pencils.
