AMENDMENT NO. 5 TO MASTER LICENSE AGREEMENT

- 2. The attached EXHIBIT 1B is added to the agreement to define the Terms for LEGO Iconic and LEGO City.
- 3. This Addendum enters into force on January 1, 2019 and expires automatically when the Agreement expires.
- Notwithstanding anything contained herein to the contrary, the effective date of any
 portion of this Amendment 5 which removes or limits the Territories that Licensee is
 permitted (as compared to that Amendment 4) to sell to shall not occur prior to
 12/31/2020.
- 5. All other provisions of the Agreement apply to this Addendum, However, if they are in conflict with this Addendum the provisions of the Addendum prevail.
